# **DRUG & ALCOHOL POLICY STATEMENT**

Onne Multipurpose Terminal (OMT) has a zero-tolerance policy and forbids the use, sale, distribution, and possession of drugs & alcohol on its premises and in its vehicles.

It is a serious offence for any employees to be under the influence of drug & alcohol or in possession or under the influence of non-prescription drug while working or residing on any property under the control of OMT.

# Our commitment is to:

- Prohibition of the use, sale, distribution, and possession of alcohol & drug while working or residing on any property under the control of the company.
- Conduct random (and when the need arises) drug and alcohol test on staff.
- Screen and test staff when there is a reasonable cause to suspect a violation of this policy or incident occurrence to determine if a person is under the influence or possession of drug and alcohol.
- Conduct search on any staff, personal effects, vehicle if suspected to be in possession of alcohol & drug within the company premises.
- Enforce a disciplinary action amounting to dismissal of any staff who resists or fails to submit himself or herself, failure to provide a specimen within a reasonable time or cooperate with testing of drug and alcohol will be viewed the same as a positive test result.
- Enforce a disciplinary action amounting to dismissal any staff in possession, use, sale and distribution of alcohol & drug or if confirmed tested positive to alcohol & drug.
- Ensure information concerning drug & alcohol test results and information concerning violations of this policy will be treated as confidential information.

All employees, contractors, customers, agents, clients, and visitors are expected to take reasonable care to ensure a zero drug & alcohol tolerance level and maintain a safe, productive work environment by preventing accidents or other dangerous incidents that may result from drug or alcohol use.

#### NO SMOKING POLICY STATEMENT

Onne Multipurpose Terminal (OMT) conducts its activities in a manner that is committed to providing a safe, healthy, and more productive environment that protects its staff from the harmful effects associated with smoking.

#### STOP WORK AUTHORITY POLICY STATEMENT

Onne Multipurpose Terminal (OMT) conducts its activities in a manner that is committed to ensure life is not threatened or in danger, equipment is not likely to get damaged and environmental incidents do not occur. OMT empowers all staff with the Authority and Responsibility to **STOP ANY WORK** if, in your opinion, you feel:

- Your life, or someone's life is in danger.
- You or someone could be injured.
- OMT/third party/client equipment/property is or could be damaged.
- The environment may get harm by pollution.
- The operation does not comply with OMT procedure and policies due to an un-safe and/or an unsafe condition developing at the job site.

When an unsafe condition is identified the Stop Work Intervention need to be initiated, in a positive manner, notify all affected personnel about the stop work issue, correct the issue and resume work when safe to do so.

No work will resume until all stop work issues have been adequately addressed.

All Stop Work Interventions shall be documented and reported for lessons learned and corrective measures to be put into place.

It is the desired outcome of any Stop Work Intervention that the identified safety concern(s) have been addressed to the satisfaction of all involved persons prior to the resumption of work.

Under no circumstance will exercising this obligation/right result in any form of retribution or intimidation. No form of retribution or intimidation directed at any staff for exercising their right to issue a stop work authority will be tolerated.

'There is always time to do it rightly', 'Do it safely or not at all', and 'Safety is everybody's responsibility'.

### **PPE POLICY STATEMENT**

Onne Multipurpose Terminal (OMT) conducts its activities in a manner that is committed to providing and maintaining a safe and healthy workplace, protecting all workers from hazard and risk using Personal Protective Equipment (PPE).

OMT management shall, where a workplace hazard cannot be eliminated or controlled at its source, provide appropriate PPE with the required level of protection is provided to workers exposed to that hazard.

#### Our commitment is to:

- Work with employees to select Personal Protective Equipment (PPE) that is safe and comfortable at all time as it is required.
- Eliminate or minimise hazards and risks to health and safety as far as is reasonably practicable. However, not all hazards can be abated entirely. PPE becomes the last line of defence.
- Conduct PPE Hazard Assessments that identify when, where and what PPE is required.
- Provide appropriate personal protective equipment and training to employees exposed to hazards requiring PPE.
- Post at designated areas requiring PPE with appropriate caution signs. These areas include foot, eye, face, head, hearing, and hand protection areas etc.
- Ensure that employees use PPE appropriately when required.
- Ensure PPE items are dedicated to one user only.
- Ensure that employees take adequate care of PPE entrusted in their care and possession.

All employees are advised to strictly follow this policy and in case of any violations, strict disciplinary actions will be taken against the violator.

# **WORKPLACE HARASSMENT POLICY STATEMENT**

### SAFE DRIVING POLICY STATEMENT

Onne Multipurpose Terminal (OMT) is committed to reducing vehicle incidents and injuries by promoting a safe driving culture within the organisation. The company takes steps to ensure vehicles are as safe as possible and will not require employees to drive under conditions that are unsafe or likely to create an unsafe environment, physical distress, or fatigue.

# **Driving rules:**

- All drivers are expected to operate within the company speed limit.
- Firearms are strictly prohibited in all vehicles operating on behalf of the company.
- All road traffic accidents must be reported.
- No carriage of person in the load carriage compartment of truck, pick up, and no rider on equipment.
- It is forbidden for any staff to be under the influence of drug or alcohol while driving and drugs and alcohol are strictly prohibited in any company vehicle.
- Driver and all passengers must ensure the use of seat belt while driving.
- Number of persons carried at a particular time must not exceed the required number or seatbelt?
- Use of mobile phone is prohibited while driving except the vehicle is stationary.
- Driver must have a valid Nigerian National Driver's Licence.
- Driver must have a valid OMT Defensive Driving training Certificate (DDC).

All employees are advised to strictly follow this policy and in case of any violations, strict disciplinary actions will be taken against the violator.

The company takes very seriously its duty of care to ensure that all drivers using company vehicles or driving any vehicle on company business in any circumstance do so in a manner that minimises the risk, both to the employee and the company.
